We are inviting you to participate in a three-week enrichment day camp focused on peace education, nature education, cultural diversity and global education, the arts, reading, writing, creative exploration and more! For current K through 5th graders in Franklin County. Breakfast, lunch and snacks are provided daily. Please note that excessive absenteeism is not acceptable as it deters other applicants on waiting lists from being able to participate. Campers are expected to attend all three weeks of camp. Remediation/enrichment will be provided by FCPS teachers each day during "star groups" for those students who are recommended.

When: June 14 – July 1, 2021; Monday through Thursday at 8am – 3pm

Where: Burnt Chimney Elementary School

Cost to families: NONE! Just like all of our Good Neighbors' programs, there is no cost to families.

Transportation: Modified bus routes will be provided by FCPS based on residences of applicants (participating students) who are FCPS students and submit their application by April 23, 2020. FCPS transportation office will notify you directly of your bus route by mail.

Apply/Register: The application form is available through your participating school and an electronic version is posted on your school's website. Please complete and submit online or return paper applications as soon as possible to a participating school office in your county. Families will receive confirmation of registration usually within 2 - 4 weeks of returning the attached form. (Please return no later than April 23, 2021)

Prioritization of acceptance of applications: Priority for acceptance goes to recommended students, returning campers and families with limited resources. The sooner you return your application, the quicker we will be able to notify families of their child's acceptance. If your child has been recommended by FCPS, your acceptance is guaranteed. Thank you!

Good Neighbors Behavior Policies

Parents:

Please remember the SML Summer Day Camp program is a privilege. We must provide an atmosphere which is conducive to safety and appropriate behavior. Maintaining proper conduct while in the Summer Day Camp program is the joint responsibility of the camper, parents, and Summer Day Camp staff. Together we can make this a great summer for everyone involved. In addition to normal FCPS policies outlined in their handbook, the following policies apply.

Policies – 2021

For your records and information

1. Policy Statement:

Discipline may take the form of "time - out" which involves the isolation of a child from the group until he/she is capable of functioning in an acceptable manner. Corporal punishment, sarcasm, and yelling by the staff are not acceptable means of disciplining children in the program. Good behavior is rewarded with praise and positive reinforcement. Parents are expected to encourage their children to follow all rules established by the staff.

2. Disciplinary Procedures:

Children who exhibit unacceptable behavior will immediately be disciplined by the Summer Day Camp Staff. If more serious disciplinary action is warranted, the parent/guardian will be notified. In such cases, the following procedure will be observed:

1st offense: Time - out and conference with student

2nd offense: Notify parents at end of day of 2nd offense by phone or when child is picked up by parent.

3rd offense: Conference with parent / guardian, Intern, and Day Camp Director.

*** NOTE: In cases of a severe discipline problem, the parent/ guardian will be notified immediately. A camper's dismissal from the program may occur at any time when: A camper's behavior is detrimental to his/her own well-being or to the well-being of others, or the camper willfully and persistently violates the rules of the camp. Hitting another child will not be tolerated and may be grounds for immediate removal from camp.

3. GENERAL RULES

The parent or guardian is asked to cooperate with all Day Camp staff and support their disciplinary efforts. Discipline is handled by the Interns or the Camp Director. The Day Camp Director will be consulted in cases of severe discipline problems.

Rules must be followed for the sake of safety, health, and acceptable behavior.

Campers must treat the interns, volunteers, and other campers with respect.

Campers shall not intentionally cause or attempt to cause physical injury to another camper or to Day Camp staff.

Campers shall refrain from rude language or conduct. Fighting will not be tolerated and violators will be subject to immediate suspension or removal from camp.

A camper shall not possess a weapon or any object which could be considered a weapon. (Examples: guns of any type, knives, razors, etc.)

No water or bathroom breaks without permission.

Please do not allow your child to bring toys or electronic devices to camp. Please have your child (ren) wear tennis-shoes to camp. NO FLIP FLOPS.
